AN INTERNAL REVIEW WAS CONDUCTED, AND THE INCIDENT WAS REPORTED TO THE BOARD OF DIRECTORS IN ACCORDANCE WITH TEEN VENTURE'S ESTABLISHED FRAUD AND WHISTLEBLOWER POLICIES. THE EMPLOYEE IS NO LONGER AFFILIATED WITH TEEN VENTURE. THE FULL AMOUNT OF \$2,700 WAS RECOVERED IN DECEMBER 2024, AND NO NET LOSS WAS INCURRED. NO GOVERNMENT OR DONOR-RESTRICTED FUNDS WERE IMPACTED. TEEN VENTURE HAS SINCE REVIEWED AND ENHANCED ITS INTERNAL FINANCIAL OVERSIGHT AND DISBURSEMENT PROCEDURES TO STRENGTHEN FRAUD PREVENTION CONTROLS.
